MUST Drug Testing

Members of MUST recognize that drug and alcohol abuse can be a serious problem for workers, their families, their workplace, and their community, and are committed to a collaborative effort to overcome the impact of drug use on safety, productivity, quality of work, and morale. MUST members are committed to providing a drug and alcohol free workforce to owners and developers, and to making Michigan the premier location in the world to showcase building with unionized construction.

The following is acknowledged by the undersigned and the Greater Detroit Building & Construction Trades Council, Michigan State Building & Construction Trades Council and Michigan Regional Council of Carpenters and its affiliated unions and other participating unions:

- a) The MUST Drug Testing Agreement is operative only with respect to the on-site construction work at the project listed below and no other project, and this MUST Drug Testing Agreement shall terminate upon completion of the listed project.
- b) The undersigned's acceptance of the MUST Drug Testing Agreement shall not be construed as voluntary recognition of any trade union or related collective agreement to which the undersigned is not already signatory, nor shall it create any collective bargaining obligation with respect to any labor organization.

MUST Safety Awareness Training

The MUST Safety Awareness Program provides standardized Safety Training that targets construction union trades and management organizations in the Michigan region. The MUST Safety Awareness Training Program in conjunction with the MUST Drug and Alcohol Screening Program seek to raise safety awareness and create an accident free workplace.

Completion of the selected MUST Safety Awareness Training Modules will be a requirement to perform work on this MUST project site. It is important to note, this safety awareness requirement is not intended to be a substitute for other health and safety and training programs defined by the scope of a project and mandated by state and federal government regulations.
